While COVID-19 has similarly impacted Port au Peck (PAP) fire company – member of the Oceanport Fire Department – we continue to serve our Oceanport community responding to Boro emergencies.

As a 100% VOLUNTEER non-profit organization, the Port-Au-Peck Fire Company provides valuable fire service protection to the residents and property owners of our community, 24 hours a day, 7 days a week and 52 weeks a year. Our personnel are well-trained, dedicated individuals who give freely of their time and efforts to provide you with the best fire protection possible. We attend approximately 24 drills per year to continue to enhance their skills in the utilization and operations all firefighting equipment, as well as continue to learn the latest firefighting techniques. Our dedicated individuals responded to over 200 emergency calls last year at all times of day and night.

As with any volunteer organization, we have operating and maintenance expenses. Every year, the Port-Au-Peck Fire Company conducts our annual fund drive at this time.
