We hope this mailing finds you well. Another year has gone by, and as with 2020, so far 2021 has been just as challenging due to the COVID-19 pandemic. Many people have been adversely impacted. However, we are hopefully starting to see the light at the end of the tunnel.

As a 100% VOLUNTEER non-profit organization, the Port-Au-Peck Fire Company (PAPFC) - a member of the Oceanport Fire Department - provides valuable fire service protection to the residents and property owners of our community, 24 hours a day, 7 days a week and 52 weeks a year. Our personnel are well-trained, dedicated individuals who give freely of their time and efforts to provide you with the best fire protection possible. We attend approximately 24 drills per year to enhance our skills in the utilization and operations all firefighting equipment, as well as continue to learn the latest firefighting techniques. Our dedicated individuals responded to over 210 emergency calls last year at all times of day and night.

COVID-19 has continued to challenge us to maintain activities to the maximum extent possible. PAPFC was challenged with maintaining readiness at all times in order to respond to Boro incidents and emergencies. As a result, we continued to serve our Oceanport community and neighbors.

As with any volunteer organization, we have operating and maintenance expenses. Every year, the Port-Au-Peck Fire Company conducts our annual fund drive at this time. As a non-profit organization in our 105th year of dedicated service to the community, we depend on you, our residents, for donations to support these expenses. The time has come this year to reach out to you for your generous tax-deductible donation. Any amount is greatly appreciated.
